On September 11, 2001, Lt. Col. Darling was working in the White House Military Office and was initially tasked to coordinate airlift assets for the President’s evacuation. However, he was quickly recruited to provide his military expertise and became a key liaison between the Vice President, National Security Advisor and the Pentagon and worked directly with the National Command Authority to respond to the terrorist attacks. Lt. Col. Darling witnessed first-hand the enormity of the crisis leadership decisions made that day on behalf of all Americans.

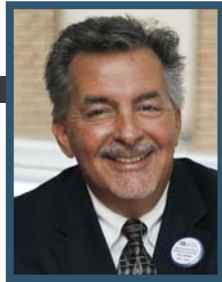

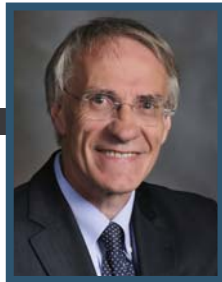
Lt. Col. Robert J. Darling

Lt. Col. Robert J. Darling, United States Marine Corps (Retired), flew Cobra attack helicopters in Desert Shield and Desert Storm and in Somalia. In 1998, he was selected to fly as a presidential pilot with Marine Helicopter Squadron One and, in October 2000, he was selected to work for The White House Military Office, Airlift Operations Department. It was in that capacity that then Major Darling supported the President, Vice President and National Security Advisor in the Presidential Emergency Operations Center (PEOC) on September 11, 2001.



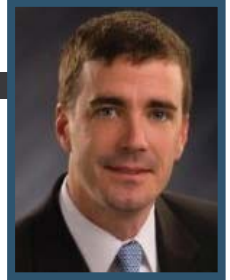
Dr. David Kohl

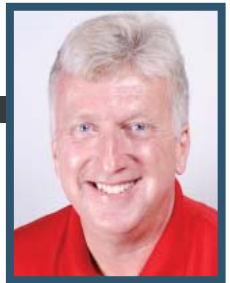
Matt Roberts

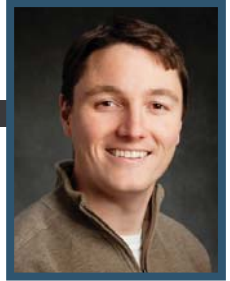
John Shutske

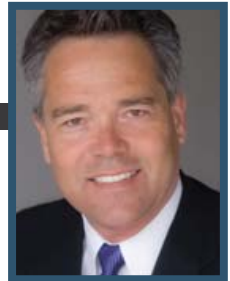
Eric Snodgrass
